- Notes from February 16 meeting:
- Proposed modification to PTW (Professional \& Technical Writing)

Certificate. In brief, the new certificate will require 12 instead of 10 credits, with a 3 credit capstone class (498P) replacing the 1 credit portfolio class (494P). Additional PTW elective classes also added (340, 412, 413, 430, 436, 440). Proposal passed 5-0.

- Proposed course: ENGL 269 Video Game Writing (Ander Monson). Focus on both writing narrative with games and writing analytically about games. Proposal passed 6-0.
- Personal note: I'm curious how this course differentiates itself from similar courses offered by the iSchool; ESOC 300 Digital Storytelling \& Culture covers very similar material for example.
- Discussion on absorbing the Professional Writing part of PTW into the CW major; RCTE would take over the Technical Writing half. Rationale for this is that a Creative and Professional Writing major (CPW) is more appealing to students and more marketable to parents and employers. Unclear how this would synergize with modifications to PTW Certificate above.
- Discussion on department recruitment efforts. Suggestions included: poster campaign (with faculty presenting posters in their classrooms); newsletter; D2L announcements; pizza party in ML building that advertises courses, books, professors. Accelerated Masters Program also considered as something to advertise to sophomores/juniors.

## New Concerns \& Homework:

- ONGOING: Remind people of travel, research, professional development, and other funding with low-stakes application processes!
- EGU Travel Awards for "official university business" travel - up to $\$ 500$ to cover costs of presenting work at a conference
- English Graduate Student Research Fund - up to $\$ 500$ for research travel/field work. Money can no longer be used for local research costs as of Spring 2022 (including buying books, transcription software, etc.)
- GPSC Travel, Research, and Professional Development grants - three separate applications for different types of opportunities; up to $\$ 750$ for eligible research travel or research project costs, up to $\$ 1500$ for eligible Professional Development costs
- GPSC Basic Needs Microgrant - up to $\$ 200$ "to alleviate some of the financial burden students might be experiencing by helping cover healthcare, academic, hygiene, childcare, transportation, and/or housing-related essential costs;" four deadlines throughout year; awarded on first-come, first-serve basis via lottery selection
